From the Bishop

This month I continue to highlight the “together” ministries of our denomination which are supported through ministry funds. This series of articles in the **EC LEADER** began with a general overview of ministry funds and then more specific articles covering the main areas of denominational work: Commissions & Committees, Church Center operations. This month I’ll highlight our affiliate support and then in May we’ll wrap it up with heritage care. There are two significant areas of denominational affiliate ministries that receive funds from ministry funds: Evangelical Seminary and our camping ministries.

Evangelical Seminary, located in Myerstown, PA, has come a long way from its humble beginnings as a school of theology in 1953.

Today Evangelical Seminary is a resource and gift from the Evangelical Congregational Church to the Kingdom of God as nearly 200 students from over twenty denominations and independent churches develop into



servant leaders for effective ministry in a broken and complex world. Our seminary emphasizes formation, not just information; allowing God to shape students’ entire being, heart and mind. Today, alumni serve the Lord all around the world with the same boldness to believe that the transformation they have experienced through Jesus is good news for the world. In addition to the traditional Master of Divinity degree, the seminary and the Center for Lifelong Learning offer degrees in marriage and family counseling and leadership, as well as Graduate

Certificates in various areas of ministry.

Our Evangelical Congregational **camping**

ministries include Camp ECCO in Carrollton, OH, Rock River Bible Camp, Dixon, IL, and Twin Pines Camp, Stroudsburg, PA. Of the three, only Camp ECCO and Twin Pines receive ministry funds with Twin Pines

receiving the largest amount. All of our camps provide children, teenagers, adults and families an op-

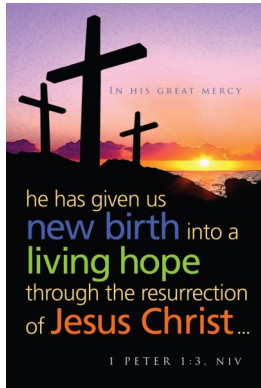


portunity to get away from the demands of the “daily grind” in order to get closer to our Creator God in an outdoor setting. Jesus both taught and practiced the need to “get away” for spiritual reflection and inspiration. Through the summer camping programs, as well as hosting retreats and meetings for local congregations, our camps provide the place and the environment where people can get away to hear from God and respond to his call on their heart. It is not an exaggeration to say that through the ministry of our camps, untold numbers of people have come to know Jesus as their Savior and have responded to his call to ministry.

The Evangelical Congregational Church has other affiliated ministries which do not

According to the *Discipline* the purpose of the Pastoral Relations Committee (PRC) shall be to aid the pastor, and any additional members of the pastoral staff, to effectively serve the needs and programs of the local congregation. It shall be a conferring and counseling committee and shall be available for consultation with the pastor concerning conditions with the local congregation that pertains to various pastoral duties.

That's what the book says, but what about real life? That's the question we want to talk about in a special training event for the members of our local Pastoral Relations Committees. A special training event will be held at two locations in each region. You only attend one event, one day, at the time and location that best fits your schedule. INTERVIEW WITH JANOR BESTWICK, Pastor at Seneca EC Church

What was your defining moment in changing your lifestyle? *I've always been very physical. I played multiple sports in both high school and college. My favorite activity was always weight lifting, but the only way I could manage my weight was through running. After a while, because there wasn't enough time in the day I had to choose one. I chose lifting. Before long my asthma got so bad I could hardly breathe just sitting on the couch. I was 5'7" and 225+ lbs. According to my height/weight chart I should be 6'4". And since the "experts" told me that there was zero chance of that hap-*

pening, it was time for a change...again.

Pastoral ministry is not considered an "active" ministry—*Being a pastor is a 24 hour job and requires more energy than you might think.*

Before that what was your attitude toward your "health"?

I've always been concerned about my health but I've also always struggled with my weight. The problem is that I know how much effort it takes and the amount of discipline required to be healthy. Unfortunately sometimes it takes a while for me to prepare myself for the commitment it takes and the self-control I so often lack.

What changes did you make? *I started running and began to eat healthier. I stopped eating at night and gave up most sweets.*

How difficult were the changes? *I find that when I really want something bad enough that it's actually pretty easy. It's when my heart's not totally in it that it's a struggle. But I've also discovered that even when it's a struggle, it's worth it.*

What support did you receive? **Does the congregation join you?** *It was a mix of support. Some were very supportive but others told me I was getting too skinny. I will be hon-*

est though, almost everyone who told me I was too skinny was overweight themselves. Many were more overweight that I was underweight. But when you lose weight as quickly as I was, it can appear pretty drastic to those who don't see you as often.

What was the impact on your spiritual life? *My health, fortunately or unfortunately, has a major impact on my spiritual life. I'm much more positive because it's easier to be happy with yourself when you know you are healthy by both how you feel and how you look. I feel better and owe it all to the Lord for giving me the self-control it took to reach my goals. I run by myself for the most part, but I feel like I'm in conversation the entire time.*

Thank you so much Janor for sharing, may you be blessed with continued success in your healthy lifestyle.



News from Benefits Corporation

Thanks for your timely attention to completing the workers compensation forms. If you have yet to do so, please submit them as soon as possible. We are waiting on the workers compensation audit and will have the invoices out to the churches by mid April. Early estimates indicate there will be a small increase to the workers compensation premiums. While we have had minimal workers compensation claims the last two years, the Commonwealth of PA has adjusted their portion of the workers compensation premium upward.

Churches not included in the denominational workers compensation group policy; Ohio, Illinois and Kentucky churches, your individual state mandates workers compensation coverage. Please confirm that all employees of the church are covered by workers compensation insurance. Per EC Benefits Corporation policy H.3.b, churches not covered by the denomination group workers compensation policy shall submit proof of workers compensation coverage by July 1 of each year. Important Changes Requiring your Attention

- 1) The recently released IRS ruling 2013-14 eliminated the tax free reimbursement by employers to employees for the cost of health insurance premiums outside of employer sponsored plans, effective January 1, 2014. Employers may no longer reimburse an employee, either by paying the employee or by pay-

ing the insurance company directly, with tax free dollars. All reimbursements by employers is taxable income (federal, social security and Medicare [FICA and/or SECA], state and local taxability is unknown at this time), to the employee. Health insurance that is part of an employer sponsored group plan is not taxable to the employee.

If a local church is paying for any employee's (pastor, administrative assistant or custodians, etc.) health insurance that is not the Highmark Blue Shield insurance offered by the denomination, in most instances, those payments are taxable income to the employee of the church. A local church can establish their own employer sponsored group health insurance plan, for unassigned pastors, part-time pastors and other non-pastoral staff to avoid the taxability of the insurance benefit. It is strongly recommended the local church consult an employee benefits attorney for proper guidance on health insurance plan design.

The same rules apply to superannuated pastors in Medicare Supplemental or Medicare Advantage plan. Only superannuated pastors in the denomination sponsored Highmark Freedom Blue plan may receive their premiums paid for by the church tax free. Any payments to the pastor or insurance company are taxable income to the superannuated pastor not in the Highmark Freedom Blue plan.

These changes are the result of the premium tax credit offered by the Affordable Care Act. An employee without access to an

employer sponsored group health insurance plan could obtain health insurance in the health insurance marketplace and receive a tax subsidy. If their employer reimburses the employee the cost of the health insurance with pre tax dollars, the employee is "double dipping" or receiving two tax saving events from the same health insurance plan, one tax benefit from the tax subsidy and the second tax benefit on the tax free payment of the cost of the health insurance premium.

- 2) All church treasurers should file IRS Form 8822-B, available at www.irs.gov. Form 8822-B notifies the IRS of a change in responsible party. The IRS is collecting a list of all responsible parties or contact persons for each EIN (employer identification number) or TIN (tax payer identification number). Form 8822-B wants the previous and current responsible party information for each EIN. If the previous responsible party is unknown, the suggested guidance is to include only the current responsible party. While there is no financial penalty for not completing the form, it is required by law. Please complete form 8822-B as soon as possible.

Any church that is using, 23-6407863, as their EIN should contact Kevin Henry, Controller, immediately and do not file form 8822-B. EIN 23-76407863 is the EIN of the National Conference. There can only be one responsible party and one entity per EIN. All local churches should have their own EIN. Please contact me and I will

help the local church obtain a separate EIN.

Susquehanna Region—July 18, 2014—First EC, Palmyra—1:00-4:00 pm

Great Lakes Region—August 11—Lakeside EC, Transfer—1:00-4:00 pm

Jennifer will be speaking on preparing financially for retirement. Mary Schell will give an overview of the current Highmark Freedom Blue plan and what does the future hold for Medicare Supplemental plans. Anyone who is currently retired or planning to retire within ten years would benefit from the presentations of Jennifer Buehler and Mary Schell.

Andrew Schreffler will review the current active pastors health insurance plan with Highmark Blue Shield and the HRA with PrimePay. Andrew will also evaluate the future of employer group health insurance and the changes resulting from the Affordable Care Act.

The seminars are open to all active pastors and their spouses, retired pastors, and their spouses, lay dele-

gates and local church leadership (board members, treasurers, etc.). Anyone can attend whichever seminar is most convenient. There is no admission cost. Registration will be required for planning purposes, electronic registration only on www.eccenter.com, beginning early May 2014.

More details to be released in early May 2014.

The annual disability premium was due January 15 and the Benefit Corporation administrative fee is due by April 15, 2014, retirees are not subject to the administrative fee. Both of these fees are listed in the Treasurer's Guide available on the EC website. Many have remitted the disability fee timely and a few have submitted the administrative fee and we thank you for your diligence and hard work.

Treasurers please begin using the 2014 Ministry Fund forms for January offerings. Offerings collected in December 2013 should be remitted on the 2013 Ministry Fund forms.

We will officially recognize Japan's National Conference status at the USA National Conference sessions held at Messiah College May 28-30. A small delegation from the EC Church of Japan will attend National Conference and be introduced at the GMC lunch on Thursday, May 29th.
